#### 2010 Regulations and Application for Flea Market/Yard Sale Dealer Participation

(This application may be photocopied for additional space reservations. Use one form per dealer.)

- 1. PRE-REGISTRATION ONLY.** There will be **no registration at the gate** on the day of each scheduled Flea Market/Yard Sale. All participating dealers **MUST** display a correctly dated confirmation card to gain admission onto the show field. You may register for all or any of the five 2010 Flea Markets as per the following schedule. Once registration fee is received, there are no refunds
- 2. SCHEDULE OF EVENTS:** Flea Markets are always scheduled for Saturdays with rain date the following day – Sunday. Call 732-919-3500 after 5:00 AM if weather is questionable. There is a recording.

\* The Superintendent of Allaire State Park reserves the right to cancel any Flea Market where it is deemed that the fields are unsuitable for parking.

- 3. REGISTRATION FEE: \$25.00 per 20' x 20' space. THERE ARE NO REFUNDS.** Applications must be postmarked no later than 7 working days before each event. Thereafter, vendor must register at the Allaire Village Office to pay for spaces and receive confirmation card. One registration form per vendor. See below for special discount opportunity.

**SHOW FIELD PARKING:** Dealer positioning on the show field will be determined by vehicle line-up order at the gate. Parking will be directed by the authorities and is single space, head-on only. Parallel parking requires two spaces. Only one vehicle is allowed to park in a space, even a double space. Vehicle longer than 30' are prohibited.

**NEW!** Vendors with large box trucks or vehicles pulling trailers **MUST** take 2 spaces.

- All on-field vehicles not displaying proper show I.D.'s are subject to ticketing and removal.
- 5. ASSISTING VEHICLE:** Dealers may be accompanied onto the show field by one vehicle (transporting additional sales items). Once unloaded, the vehicle must be parked along the tree line at the rear of the show field. There is a \$3.00 parking fee which must be paid at the time of registration. The dealer will be provided with that vehicle's admission card at the same time the space registration card is mailed.

6. **SET-UP TIME**: Depending on the date of event, gates open at 6:00, 6:30, 7:00 or 7:30. Vendors are welcome to arrive earlier but there will be no access to the Park before that time. Only by simultaneous arrival can two dealers be certain that they will be parked together. Dealers will not be permitted to hold adjacent spaces for later arriving dealers.
7. **PUBLIC ARRIVAL**: 8:00 AM – 3:00 PM. Sales may continue past 3:00 PM so that latecomers will not be disappointed.
8. **ACCOMODATIONS**: Dealers must supply their own tables, tents, chairs, etc. Electricity is not provided. Items for sale must be displayed within the space. Do not display items in the center of an isle.
9. **DEBRIS DISPOSAL**: Dealers must recognize that Allaire State Park is a “CARRY-IN, CARRY-OUT” facility and abide by the Park’s rules regarding refuse disposal – All trash, litter or debris brought into the Park or generated while in the Park must be taken with you when you leave. This includes all packing material, cardboard boxes and unsold items. There are no dumpsters or other trash receptacles on site.
10. **NOT PERMITTED**: Dealers may not display or sell food, beverages, any form of armory including but not limited guns, knives, bows, arrows, swords. Additionally illegally trademarked items and items deemed by Allaire Village, Inc. to be obscene or salacious are prohibited.
11. Allaire Village, Inc. and Allaire State Park/NJDEP will not be responsible for any damage by fire, theft or any other cause.

**ADDITIONAL DISCOUNT OPPORTUNITY**: If the first four events are booked and paid for prior to 05/01/10, there will be no charge for the fifth event. This is a space for space offer. If two spaces are reserved for each of the first four events by 05/01/10, the no charge offer will apply to two spaces at the fifth event. Assisting Vehicle discount is not included in this offer.
